壹、入學時間及修業年限(Enrollment Time and Study Duration)

- 一、入學時間：2026 年 09 月（秋季班）入學，每學年包含 2 個學期。

Enrollment Time: Admission is in September 2026 (Fall Semester). Each academic year consists of two semesters.

- 二、修業年限：學士班四至六年為限。

Duration of Study: The undergraduate program must be completed within four to six years.

- 三、大學部畢業總學分至少 128 學分

Undergraduate students are required to complete a minimum of 128 credits for graduation.

貳、申請資格(Application Qualifications)

一、身分資格(Identity Requirements)

申請人須符合教育部「外國學生來臺就學辦法」規定，並於國內大學或獨立學院修業滿一學年，且未因前述辦法內第十二條規定致遭退學者。

Applicants must meet the requirements set forth in the Ministry of Education's "Regulations Regarding International Students Undertaking Studies in Taiwan," and must have completed at least one academic year at a domestic university or independent college. Applicants who have been expelled under Article 12 of the aforementioned regulations are not eligible to apply.

註一：根據「中華民國國籍法」第 2 條規定，有下列各款情形之一者，屬中華民國國籍：

Note 1: According to Article 2 of the Nationality Law, a person who meets one of the following requirements acquires the nationality of the Republic of China:

- 一、出生時父或母為中華民國國民。【*】

A person whose father or mother was, at the time of his/her birth, a citizen of the Republic of China. 【*】

- 二、出生於父或母死亡後，其父或母死亡時為中華民國國民。【*】

A person born after the death of his/her father or mother, and whose parent was, at the time of death, a citizen of the Republic of China. 【*】

- 三、出生於中華民國領域內，父母均無可考，或均無國籍者。

A person born in the territory of the Republic of China and whose parents are both unknown or are stateless.

- 四、歸化者。

A naturalized citizen.

【*】1980 年 2 月 9 日前出生者，僅以父親國籍為準。

註二：大學或獨立學院在學學生報名時，因最後一學期成績單學校尚未寄發，可先行報名。倘錄取後未能繳交歷年成績單，或遭退學者，即取消其錄取資格。

【*】An individual born on or before February 9, 1980 only needs to consider the nationality of his or her father. Note 2: An applicant currently studying at any university/college in Taiwan can apply first before receiving the transcript for the final academic semester. Provided that an applicant fails to submit transcripts for each academic semester or is expelled from the university/college after being admitted to CTBC University of Technology, his/her admission will be immediately revoked.

二、學歷資格(Academic Qualifications)

(一) 目前須就讀於我國大專校院學士班或副學士畢業之外國學生。

Foreign students who are currently studying in undergraduate programs or have graduated from associate degree programs at colleges or universities in Taiwan.

(1) 國內公立或已立案之私立大學之肄業生，申請轉學進入本校繼續修讀學士學位者，應另符合修業期程規定：修業累計滿二個學期以上者，得轉入二年級上學期；修業累計滿四個學期以上者，得轉入三年級上學期。

Students who have withdrawn from public or officially registered private universities in Taiwan and wish to transfer to our university to continue pursuing a bachelor's degree must also comply with the study duration regulations: those who have completed at least two semesters may transfer into the first semester of the second year; those who have completed at least four semesters may transfer into the first semester of the third year

(2) 已畢業或錄取報到時已畢業者不符合申請資格。

Applicants who have already graduated, or will have graduated by the time of enrollment, are not eligible to apply.

(3) 外國學生經原入學學校以操行不及格或因刑事案件經判刑確定致遭退學者，不得轉學進入本校就讀。

Foreign students who have been expelled from their original institution due to failing conduct evaluations or a final criminal conviction are not allowed to transfer to our university.

三、語言資格(Language Proficiency)

本校各系以華語授課為原則，申請者須具備華語文能力，並繳交華語文能力測驗（TOCFL）基礎級 A2（含）或相當於 CEFR A2（含）以上之國際通用中文能力證明，未達語言能力門檻者不予錄取。

All academic departments at the University conduct instruction primarily in Chinese. Applicants are required to possess Chinese language proficiency and submit proof of Chinese language proficiency, either the Test of Chinese as a Foreign Language (TOCFL) at Level A2 (inclusive) or another internationally recognized Chinese language proficiency certificate equivalent to CEFR A2 (inclusive) or above. Applicants who do not meet the required language proficiency threshold shall not be admitted.

四、財力資格(Financial Requirements)

1. 國際一般生財力證明以美金3,500元為原則(應符合當地駐外館公告之基本標準為核)。

The financial proof for general international students should amount to USD 3,500 as a basic principle (in line with the basic standard announced by local embassies or representative offices).

2. 學生擁有政府、大專校院或民間機構提供全額獎助學金證明，應提供本校及外館審核。

Students who have full scholarships provided by governments, universities, or private organizations must provide proof for verification by the university and the local embassy or representative office.

3. 財力證明不得採用代辦、公司行號或個人開立證明。

Financial proof cannot be issued by agents, companies, or individuals.

4. 學生還沒有最終的正式財力證明前，得要求學生先提供同一戶家人或足以證明為親屬關係之存款簿照片證明(或當地銀行開立之存款證明)。

Before the final formal financial proof is obtained, students may be asked to first provide a photograph of a family member's bank passbook or proof of savings (or a bank statement issued by a local bank) demonstrating their financial connection.

一、申請期限：2026 年 06 月 26 日為原則。

Application Deadline: In principle, the deadline is June 26, 2026.

Important Notes:

All application documents specified in this prospectus that require completion or signature must be personally completed and signed by the applicant. The applicant shall be solely responsible for the accuracy and authenticity of all information provided.

2. 申請資料寄〈送〉達後，經本校審查後發現報名資格不符、表件資料不全或逾期繳件而遭取消申請資格，概由申請者自行負責。所有已寄〈送〉之申請文件一概不退還，請自

Once application documents are submitted and reviewed by the school, if any discrepancies, incomplete documents, or late submissions are found, the applicant is responsible for the cancellation of their application. All submitted documents will not be returned, so applicants should keep copies for themselves.

3. 申請者所繳之任何證明文件，經查如有偽造、變造、假借、冒用、不實者，未入學者取消錄取資格，已入學者開除學籍並不發給修業有關之任何證明文件，已畢業者或退學者除註銷學籍並繳銷其學位證書或修業證明書。涉及刑法偽造文書之刑責部份者，依法移送司法機關究辦。

If any submitted documents are found to be forged, altered, borrowed, falsely used, or fraudulent, the applicant's admission will be canceled if not yet enrolled. For enrolled students, their student status will be revoked, and no documents related to their academic achievements will be issued. For graduates or those who have withdrawn, their student status will be canceled, and their degree certificates or study certificates will be annulled. Cases involving the criminal offense of document forgery will be referred to judicial authorities for prosecution in accordance with the law.

伍、甄選方式(Selection Method)

本校招收外國學生轉學生，經初審合格者，則呈送相關申請系進行書面資料審查與評分，合格者擇優錄取。

CTBC University of Technology accepts foreign transfer students. Those who pass the preliminary review will have their application materials forwarded to the respective departments for document review and evaluation. Among those who meet the requirements, admission will be offered based on merit.

Admitted students who have completed the check-in process are required to complete the registration procedures by the deadline specified in the enrollment permit issued by the university.

三、經審查通過進入各系就讀學生，若華語能力尚須加強者，各系得強制要求參加本校之華語訓練課程。

Students who pass the review and are admitted into their respective departments/programs may be required to attend the university's Chinese language training courses if their Chinese proficiency needs improvement.

捌、繳費標準 (Payment Standards)

一、大學部學雜費

Undergraduate tuition and miscellaneous fees

1. 學雜費皆依教育部規定：半導體工程學院約 51,450 元/學期；管理暨設計學院、健康休閒學院約 44,820 元/學期。

Tuition and miscellaneous fees are charged in accordance with the Ministry of Education regulations: approximately NT\$51,450 per semester for the College of Semiconductor Engineering, and approximately NT\$44,820 per semester for the College of Management and Design and the College of Hospitality and Leisure.

2. 另須繳交其他費用：電腦網路使用費新臺幣 1,050 元/學期、學生平安保險費：700 元/學期、全民健康保險費（來臺滿六個月後開始繳交）新臺幣 4,956 元/學期。入學後，未取得全民健保資格的前六個月須強制參加外國學生醫療保險每個月 500 元，半年 3,000 元。
Additional fees include: computer network usage fee of NT\$ 1,050 per semester, student insurance fee of NT\$ 700 per semester, and National Health Insurance fee of NT\$ 4,956 per semester (payable after six months in Taiwan). During the first six months after enrollment, students who do not qualify for National Health Insurance must participate in the foreign student medical insurance, which costs NT\$ 500 per month (NT\$ 3,000 for six months).
3. 校內住宿：基本型雅房：8,500 元/1 學期，精緻型雅房：13,500 元/1 學期，套房：18,000 元/1 學期，申請時須預繳住宿費保證金新臺幣 3,000 元整；退宿並完成寢室檢查後歸還。
On-campus Housing: Basic shared room: NT\$8,500 per semester; Deluxe shared room: NT\$13,500 per semester; Suite: NT\$18,000 per semester. A housing deposit of NT\$3,000 is required at the time of application and will be refunded after moving out and completion of the dormitory inspection.

玖、學雜費退費基準(Tuition and Fees Refund Criteria)

- 一、註冊日（含當日）前申請休退學者：免繳費，已收費者，全額退費。

Students who apply for withdrawal or suspension on or before the registration day (inclusive)

are not required to pay any fees. If payment has already been made, a full refund will be issued.

二、於上課（開學）日（含當日）之後而未逾學期三分之一申請休、退學者

Students who apply for suspension or withdrawal on or after the first day of class (inclusive) but before one-third of the semester has elapsed:

1.學費、雜費退還三分之二。

Two-thirds of the tuition and miscellaneous fees will be refunded.

2.採學分學雜費或學雜費基數核算者，退還學分費、學雜費基數（或學分學雜費）各三分之二。

For students whose fees are calculated based on credit units or a fee base, two-thirds of both the credit fees and the base amount (or credit-based fees) will be refunded.

三、於上課（開學）日（含當日）之後逾學期三分之一，而未逾學期三分之二申請休、退學者。

Students who apply for suspension or withdrawal after one-third but before two-thirds of the semester has elapsed (inclusive of the first day of class):

1.學費、雜費退還三分之一。

One-third of the tuition and miscellaneous fees will be refunded.

2.採學分學雜費或學雜費基數核算者，退還學分費、學雜費基數（或學分學雜費）各三分之一。

For students whose fees are calculated based on credit units or a fee base, one-third of both the credit fees and the base amount (or credit-based fees) will be refunded.

四、於上課（開學）日（含當日）之後逾學期三分之二申請休、退學者。

Students who apply for suspension or withdrawal after two-thirds of the semester has elapsed (inclusive of the first day of class):
