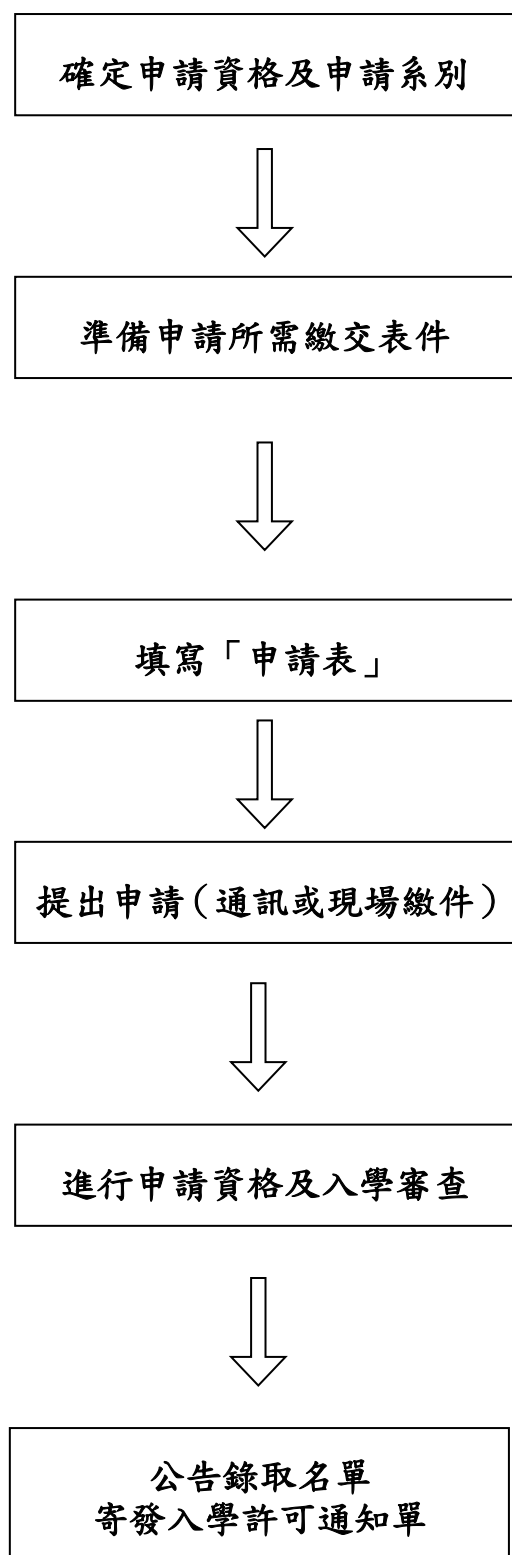

◇ **申請報名截止日期：2025年12月31日為原則**

◇ 繳交表件：

1. 最高學歷畢業證書 (或在學證明、同等學歷證明、臨時畢業證書)
2. 成績單 (畢業前的六個學期)
3. 書面資料
4. 身分及學歷資格聲明書(切結書)
5. 香港或澳門居民報名資格確認書
6. 語言檢定證明
7. 財力證明 (參閱P.6財力資格)

◇ 填寫「入學申請表」(附表二) 並詳細檢查確認資料，一旦寄出後，均以申請資料為準，請申請人審慎行事。

※請於繳交資料檢核表(附表一)上逐項勾選需繳交之表件。

◇ 所有報名表件請通訊寄件或現場繳件 (建議使用DHL或FedEX快遞)

壹、入學時間及修業年限(Enrollment Time and Duration of Studies)

一、入學時間：2026 年 02 月（春季班）入學，每學年包含 2 個學期。

Enrollment Time: Admission is on February, 2026 (Spring Semester), and each academic year consists of 2 semesters.

二、修業年限：大學部一至四年；碩士班一至二年。

Duration of Study: Bachelor programs last between 1 to 4 years; Master's programs last between 1 to 2 years..

三、大學部畢業總學分至少 128 學分；碩士班畢業總學分半導體工程學院至少 31 學分、管理暨設計學院、健康休閒學院至少 28 學分。

Undergraduate students are required to complete a minimum of 128 credits for graduation. For master's programs, a minimum of 31 credits is required for students in the College of Semiconductor Engineering, and a minimum of 28 credits is required for students in the College of Management and Design and the College of Health and Leisure.

貳、申請資格(Eligibility Requirements)

僑生及港澳學生申請資格係依據教育部「僑生回國就學及輔導辦法」及「香港澳門居民來臺就學辦法」之規定，辦法如經修訂，以教育部公告為準。

符合下列資格者，得向本校提出入學申請：

The eligibility of Overseas Chinese and Hong Kong and Macao students is based on the Ministry of Education's regulations "Guidelines for Overseas Chinese Returning to Study" and "Guidelines for Hong Kong and Macao Residents Studying in Taiwan". Any amendments will be subject to the Ministry of Education's announcements.

Applicants who meet the following criteria can apply for admission to our school:

一、身分資格(Identity Requirements)

海外出生連續居留迄今，或最近連續居留海外六年以上，並取得僑居地永久或長期居留證件回國就學之華裔學生。香港或澳門（以下簡稱港澳）居民，具有港澳永久居留資格證件，且最近連續居留港澳或海外六年以上；並符合「香港澳門關係條例」第四條規定，未持有外國護照者。且以當年度自海外回國者為限(不含已在臺就讀高級中等學校、國內大學一年級肄業及國立臺灣師範大學僑生先修部結業之僑生及港澳生)。

Students of Chinese descent who were born overseas and have continuously resided abroad up until now or have resided overseas for more than six consecutive years and have obtained permanent or long-term residency in their overseas place of residence. Hong Kong or Macao residents (hereinafter referred to as "Hong Kong and Macao") who have permanent residency in Hong Kong or Macao, have resided in Hong Kong, Macao, or overseas for more than six consecutive years, and meet the requirements of Article 4 of the "Hong Kong and Macao Relations Ordinance" without holding a foreign passport. Applicants are limited to those returning from overseas in the current year (excluding those already studying at a senior secondary school,

freshmen in domestic universities, or graduates of the preparatory program for Overseas Chinese students at National Taiwan Normal University).

1. 所稱海外，指大陸地區、香港及澳門以外之國家或地區。

The term "overseas" refers to countries or regions outside Mainland China, Hong Kong, and Macao.

2. 所謂「連續居留」係指「每曆年（1月1日至12月31日）在臺灣地區停留期間不得逾120日，期間係以本簡章申請時間截止日為計算基準日往前回溯推算六年。但計算至西元2024年8月31日始符合本簡章所訂連續居留年限規定者，亦得申請。

"Continuous residence" means that the period of stay in Taiwan in any calendar year (from January 1 to December 31) must not exceed 120 days. The six-year period is counted backward from the application deadline specified in this brochure. However, applicants who meet the continuous residence requirement by August 31, 2024, are also eligible to apply.

3. 「香港澳門關係條例」第四條規定，所稱香港居民係指具有香港永久居留資格，且未持有英國國民（海外）護照或香港護照以外之旅行證照者；所稱澳門居民係指具有澳門永久居留資格，且未持有澳門護照以外之旅行證照或雖持葡萄牙護照但係於葡萄牙結束治理前於澳門取得者。

According to Article 4 of the "Hong Kong and Macao Relations Ordinance," a "Hong Kong resident" refers to someone with permanent residency in Hong Kong and who does not hold a British National (Overseas) passport or any travel documents other than a Hong Kong passport. A "Macao resident" refers to someone with permanent residency in Macao who does not hold a Macao passport or, if holding a Portuguese passport, obtained it before Portugal ended its administration of Macao.

4. 申請人如符合下列情形之一者，不以連續僑居中斷論；其在臺灣地區停留期間不併入港澳或海外居留期間計算（也就是港澳或海外連續居留時間須往前推算）。請於報名時檢附證明文件一併繳交，以利審核。

Applicants who meet any of the following conditions will not be considered as having interrupted their continuous overseas residence. Their stay in Taiwan will not be counted toward the time of continuous residence in Hong Kong, Macao, or overseas (the continuous residence period must be calculated backward). Please attach proof documents when applying to facilitate review.

- (1) 就讀僑務主管機關舉辦之海外青年技術訓練班或中央主管教育行政機關認定之技術訓練專班。

Attending an overseas youth technical training class organized by the Overseas Community Affairs Council or a technical training program recognized by the central education administration authority.

- (2) 就讀僑務主管機關舉辦之研習班或函介之國語文研習課程，或參加經僑務主管機關認定屬政府機關舉辦之活動，其研習或活動期間合計未滿二年。

Attending a study class or Mandarin language training course organized by the Overseas

二、學歷資格 Academic Requirements

- (一) 在當地華文中學、外文中學畢業或相當於中華民國高級中學畢業取得畢業證書（以同等學力資格申請者須附修業證明書），且經我政府駐外館處查證屬實者。

Applicants must have graduated from a Chinese or foreign secondary school abroad with a diploma equivalent to a Taiwanese senior high school diploma (those applying with equivalent qualifications must attach proof of completion of studies), which has been verified by Taiwan's overseas embassies or consulates.

- (二) 相當於中華民國高級中等學校肄業或畢業年級，高於相當中華民國高級中學學校之國外同級同類學校肄業並修滿相當於中華民國高級中學學校修業年限以下年級，符合下列資格之一者，或畢業年級相當於中華民國高級中等學校二年級之國外同級同類學校畢業生，得以同等學力資格申請：

Those who have completed or are in the graduating year of a foreign school equivalent to a senior high school in the Republic of China (Taiwan), or those who have completed a lower grade than the equivalent of the full duration of a senior high school in the Republic of China but meet one of the following qualifications, or graduates from a foreign school equivalent to the second year of a senior high school in the Republic of China, may apply under the qualification of equivalent academic achievement:

- (1) 僅未修習規定修業年限最後一年，因故休學、退學或重讀二年以上。

Those who have not completed the final year of the required duration due to suspension, withdrawal, or repeating the same year for more than two years.

- (2) 修滿規定修業年限最後一年之上學期，因故休學或退學一年以上。

Those who have completed the first semester of the final year of the required duration, but have suspended or withdrawn from school for more than one year.

- (3) 修滿規定年限，因故未能畢業。

Those who have completed the required duration but have been unable to graduate due to other reasons.

上述休學、退學或重讀年數之計算，自修業證明書或休學證明書所附具歷年成績單所載最後修滿之截止日期起，計算至報考當年度註冊截止日為止。

The calculation of the period of suspension, withdrawal, or repeating the year mentioned above is based on the date indicated in the transcript attached to the proof of study or suspension certificate and is counted up to the registration deadline of the year in which the applicant is applying.

- (三) 同等學力資格之認定應依教育部「入學大學同等學力認定標準」之規定辦理。

The recognition of equivalent academic qualifications shall be handled in accordance with the Ministry of Education's "Standards for the Recognition of Equivalent Academic Qualifications for University Admission."

※ 凡有下列情形之一者，不得依本簡章之規定申請回國升學，違反規定者，取消錄取資格；已入學者，應令退學並撤銷學籍。

※ Applicants who meet any of the following conditions are not eligible to apply for returning to Taiwan for further studies under the provisions of this brochure. Violators will have their admission revoked, and if already enrolled, they will be expelled and their student status canceled.

(1) 已申請喪失中華民國國籍經核准有案且尚未取得他國國籍者。

Those who have applied for and been approved for the renunciation of Republic of China nationality but have not yet acquired the nationality of another country.

(2) 持偽造或冒用、變造證明文件或護照者。

Those who hold forged, altered, or misused certificates or passports.

(四) 申請碩士班入學擁有副學士學位，以大學同等學力資格之認定報名，應依教育部「入學大學同等學力認定標準」之第五條第四款規定辦理。

Applicants for master's programs who hold an associate degree and apply under the recognition of equivalent academic qualifications for university admission must follow the provisions of Article 5, Section 4 of the Ministry of Education's "Standards for the Recognition of Equivalent Academic Qualifications for University Admission."

三、語言資格(Language Proficiency)

全校各系授課語言是華語為原則，語言能力門檻要求(應符合當地駐外館公告之基本法規標準為核)：

The language of instruction for all departments is Chinese. The language proficiency requirements should meet the basic regulatory standards announced by local embassies or representative offices:

1. 應具有華語文能力者，須繳交華語文能力測驗(TOCFL)基礎版A2(含)級或相當於CEFR基礎級A2(含)以上之中文能力證明。

Applicants with Chinese language proficiency must submit a certificate of Chinese proficiency, such as a TOCFL A2 (Basic) or a certificate equivalent to CEFR A2 (Basic) or above.

2. 需於開學前取得華語文能力證明文件，未於開學前取得者將取消入學資格。

The Chinese proficiency certificate must be obtained before the start of the semester. Failure to do so will result in the cancellation of admission.

四、財力資格 Financial Requirements

1. 財力證明以美金3,500元為原則(應符合當地駐外館公告之基本標準為核)。

Proof of financial stability must be demonstrated by showing at least USD 3,500 (this must meet the basic standard set by the local Taiwan representative office).

2. 學生擁有政府、大專校院或民間機構提供全額獎助學金證明，應提供本校及外館審核。
Students who have received full scholarships from the government, a university, or a private organization must submit the relevant proof to the school and the overseas office for verification.

3. 財力證明不得採用代辦、公司行號或個人開立證明。

Financial proof must not be provided by agents, companies, or individuals.

4. 學生還沒有最終的正式財力證明前，得要求學生先提供同一戶家人或足以證明為親屬關

係之存款簿照片證明(或當地銀行開立之存款證明)。

Before the student submits the final official proof of financial capacity, the student may be asked to provide a photo of a family member's bankbook from the same household or other documentation proving kinship (or a bank statement issued by a local bank).

肆、申請方式及日期(Application Deadline and Methods)

一、申請期限：2025 年 12 月 31 日為原則。

Application Deadline: Before J Dec 31, 2025.

二、申請方式：採通訊申請（以郵戳為憑）或現場繳件。

Application Method: Applications may be submitted by mail (postmark as proof) or in person.

三、申請者應於前述申請期間內，檢附下列文件向本校國際事務處申請：

Applicants should submit the following documents to the department of international studies of the school within the application period:

Completed Application Form (Refer to Form 1. Please attach a 2-inch, hatless, half-body photo. The application form must be signed personally by the applicant.)

【港澳生】：[Hong Kong and Macao students]:

- (1) 港澳護照及永久居留資格證件影本。

Copy of Hong Kong or Macao passport or permanent residency certificate

Original proof of continuous residence in Hong Kong, Macao, or overseas.

- (3) 回鄉證（大陸地區出生之港澳地區學生限定）

Mainland Travel Permit for Hong Kong and Macao Residents (eligible only for Hong Kong or Macao students born in Mainland China)

- (4) 香港或澳門居民報名資格確認書（附表四）

Eligibility Confirmation Form for Hong Kong or Macao Residents (Form 4)

3. 身分及學歷資格聲明書（切結書）（如附表三）

Declaration of identity and academic qualifications (Form 3)

4. 僑生及港澳生（具）切結書（如附表五）

Affidavit for Overseas Chinese Students and Students from Hong Kong and Macao (Form 5)

5. 最高學歷之外國畢業證書正本一份（註 1），暨該證書之英文或中文譯本一份（須經畢業學校所在地之中華民國駐外館處驗證並加蓋認證章戳）；應屆畢業生須於錄取報到時補交，否則取消錄取資格。

註 1：報名時請繳交經駐外館處驗證之畢業證書影本一份；影本須清晰呈現驗證章戳。本校僅留存影本，不收正本。

6. 最高學歷之外國畢業證書影本（一份），請提供經畢業學校所在地之中華民國駐外館處驗證並加蓋認證章戳之畢業證書影本，影本須能清晰呈現驗證章戳。若畢業證書內容非中文或英文，請另附中文或英文譯本一份，且該譯本亦須經駐外館處驗證。應屆畢業生如於報名時尚未取得畢業證書，須於錄取報到時補交，否則取消錄取資格。

A photocopy of the highest foreign diploma must be submitted. The document must be verified and stamped by an ROC (Taiwan) overseas mission located in the country where the diploma was issued, and the photocopy must clearly display the verification stamp. If the diploma is issued in a language other than Chinese or English, a Chinese or English translation must also be provided, and the translation must likewise be verified by the overseas mission. Applicants who have not yet obtained their diploma at the time of application must submit it upon enrollment; failure to do so will result in the cancellation of admission.

- ※ 錄取報到時，申請學士班者繳交高中畢業（結業）證書，申請碩士班者繳交副學士以上學位證書（只有專科學歷者，須提出五年以上與申請該系所碩士班相關之工作證明正本）；於驗證後歸還。

At the time of registration, bachelor's applicants must submit a high school graduation (completion) certificate, while master's applicants must submit an associate degree or higher. (Applicants with only technical/vocational education must submit the original proof of more than five years of relevant work experience for the master's program being applied for.) Documents will be returned after verification.

7. 中文或英文歷年成績單一份（須經由畢業學校加蓋認證章戳或鋼印）。

One official academic transcript in Chinese or English (must be stamped by the graduating school).

Applicants for the bachelor's program must submit their complete high school transcripts, and applicants for the master's program must submit their complete university transcripts.

At the time of registration, original documents must be submitted and will be returned after verification.

Financial Proof (USD 3,500). If the bankbook belongs to the applicant's parents, a certificate of family relationship must be attached.

Once application documents are submitted and reviewed by the school, if any discrepancies, incomplete documents, or late submissions are found, the applicant is responsible for the cancellation of their application. All submitted documents will not be returned, so applicants should keep copies for themselves.

If any of the submitted documents are found to be forged, altered, borrowed, falsely used, or otherwise fraudulent, the applicant's admission shall be revoked if the individual has not yet enrolled. For those already enrolled, their student status shall be terminated, and no academic certificates or transcripts will be issued. For those who have graduated or withdrawn, their student status and degree or study certificates shall be annulled. Cases involving violations of criminal law related to document forgery will be referred to the judicial authorities for legal investigation and prosecution.

Documents will be reviewed by relevant departments, and the Admissions Committee will make the final decision on admissions.

Tuition and miscellaneous fees are charged in accordance with the Ministry of Education regulations: approximately NT\$51,450 per semester for the College of Semiconductor Engineering, and approximately NT\$44,820 per semester for the College of Management and Design and the College of Hospitality and Leisure..

2. 以本管道入學者，享有以下助學金優惠（本助學金僅適用於新南向國家學生）。

Students admitted through this channel are entitled to the following scholarship benefits (this scholarship is only applicable to students from New Southbound countries).

Tuition and miscellaneous fees are waived for the first semester, and shared-room dormitory accommodation is provided free of charge. Conditions for eligibility for national university tuition rates and free shared-room dormitory accommodation in the second semester:

A. No record of unexcused absences in the previous semester.

B. A conduct grade of 80 or above.

C. No more than 14 periods of personal leave, and no disciplinary action resulting in a demerit or higher.

- 二、 碩士班學生只須繳交學分費，每學分新臺幣 6,250 元，半導體工程學院共 31 學分；管理暨設計學院、健康休閒學院共 28 學分。修業年限 1-4 年。

Master's program students are only required to pay credit fees. Each credit costs NT\$ 6,250.

The College of Semiconductor Engineering requires 31 credits, while the College of Management and Design, and the College of Hospitality and Leisure require 28 credits.

The duration of study is 1 to 4 years.

During the first six months after enrollment, students who do not qualify for National Health Insurance must participate in the foreign student medical insurance, which costs NT\$ 500 per month (NT\$ 3,000 for six months).

On-campus accommodation requires a deposit of NT\$3,000, which will be refunded after the student completes the checkout process and the room inspection.

For those who use the credit tuition or tuition base to calculate, all credit fees and two-thirds of the tuition base (or credit tuition) will be refunded.

Students who apply for leave of absence or withdrawal after the first day of class (including the first day of school) but within one third of the semester.

Two-thirds of tuition and miscellaneous fees will be refunded.

For those who use the credit tuition or tuition base to calculate, two-thirds of the credit fee and tuition base (or credit tuition) will be refunded.

Students who apply for leave of absence or withdrawal after more than one-third of the semester but less than two-thirds of the semester after the first day of class (including the first day of school).

One third of tuition and miscellaneous fees will be refunded.

2. 採學分學雜費或學雜費基數核算者，退還學分費、學雜費基數（或學分學雜費）各三分之一。

For those who use the credit tuition or tuition base to calculate, one third of the credit fee and one third of the tuition base (or credit tuition) will be refunded.

Students who apply for leave of absence or withdrawal more than two-thirds of the semester after the first day of class (including the first day of school).

If admitted students fail to meet the Overseas Chinese or Hong Kong and Macao identity verification by the Overseas Community Affairs Council or the Ministry of Education, the school will cancel their admission without objecti

Admission approval does not guarantee a visa. The visa must be granted by the ROC overseas missions.

Overseas Chinese and Hong Kong and Macao students admitted through this channel may not independently transfer to other educational institutions such as evening schools, adult continuing education programs, or distance learning programs, including part-time master's programs. However, those who have obtained legal residency in Taiwan for reasons other than studying are exempt from this restriction.

Overseas Chinese students and Hong Kong/Macao students admitted to this university through this enrollment channel are not allowed to independently transfer to or enroll in any remedial or continuing education schools (institutes), open universities or open colleges, continuing education bachelor's programs, executive master's programs, or other programs that only offer night or weekend classes. However, Overseas Chinese students and Hong Kong/Macao students who have obtained legal residency in Taiwan for reasons other than education may enroll in executive master's programs. If Overseas Chinese students and Hong Kong/Macao students violate the aforementioned regulations, the university will revoke their enrollment or transfer, and no related academic certification will be issued. If the violation is discovered after graduation, their graduation qualifications will be revoked, and their degree certificates will be reclaimed or nullified.

The university's Department of international study will arrange overseas Chinese health and accident insurance for new students after the start of the semester. Once a student has resided in Taiwan for more than 180 days without leaving the country (and any single trip abroad does not exceed 30 days), they will qualify for National Health Insurance (NHI). If they do not meet the above requirements, the school will assist them in purchasing foreign student health and accident insurance until they qualify for NHI.

When registering, foreign students may submit proof of health and injury insurance that is valid for at least six months from the date of entry. If the insurance certificate is issued abroad, it must be verified by an overseas ROC representative office.
