壹、入學時間及修業年限(Enrollment Time and Study Duration)

一、入學時間：2025 年 09 月（秋季班）入學，每學年包含 2 個學期。

Enrollment Time: Admission is on September, 2025 (Fall Semester), and each academic year consists of 2 semesters.

二、修業年限：大學部一至四年。

Duration of Study: Bachelor programs last between 1 to 4 years

三、畢業總學分至少 128 學分

The total number of credits completed to be eligible to graduate shall not be less than 128 credits

貳、申請資格(Application Qualifications)

外國生申請資格係依據教育部「外國學生來臺就學辦法」之規定，辦法如經修訂，以教育部公告為準。

The qualifications for foreign students are based on the Ministry of Education's "Regulations Regarding International Students Undertaking Studies in Taiwan." Should these regulations be amended, the announcement from the Ministry of Education will take precedence.

一、具外國國籍且未曾具有中華民國國籍，符合下列規定者，得依本辦法規定申請入學：

Foreign nationals who have never held Republic of China (ROC) nationality and meet the following conditions are eligible to apply for admission under these regulations:

(一) 未曾以僑生身分在臺就學。

Have never studied in Taiwan as an Overseas Chinese student.

(二) 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

Have not been assigned for admission in the same academic year of application through the Overseas Joint Admissions Committee under the Regulations for Overseas Chinese Students Returning to Study.

具外國國籍且符合下列規定，且最近連續居留海外六年以上者，亦得依本辦法規定申請入學：
Foreign nationals who meet the following conditions and have continuously resided overseas for more than six consecutive years may also apply for admission under these regulations:

(一) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

Applicants who also held ROC nationality at the time of application must not have had household registration in Taiwan at any point.

(二) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

Applicants who had ROC nationality before but no longer hold it at the time of application must have had their ROC nationality revoked by the Ministry of the Interior at least eight years prior to applying.

(三) 前二款均應符合前項第一款及第二款規定。

The first two paragraphs shall comply with the provisions of the first and second paragraphs of the preceding paragraph.

依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經教育部核准，得不受前二項規定之限制。

Foreign nationals who have been recommended for study in Taiwan by foreign governments, institutions, or schools according to educational cooperation agreements, and who have never had household registration in Taiwan, may be exempt from the aforementioned restrictions upon approval by the Ministry of Education.

第二項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

The six or eight years specified in the second item are calculated as ending on the start date of the intended semester of enrollment (either February 1 or August 1).

第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間不得逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The term "overseas" in the second item refers to countries or regions outside Mainland China, Hong Kong, and Macau. "Continuous residence" means that the foreign student may not stay in Taiwan for more than 120 days in any calendar year. For periods of continuous residence overseas that do not constitute a full calendar year, the period within which the student did not stay in Taiwan for more than 120 days will be counted for each respective year. However, the following circumstances, if supported by relevant documentation, are exceptions; the time spent in Taiwan will not be included in the calculation of the overseas residence period:

(一) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

Attending overseas youth technical training classes held by the Overseas Community Affairs Council or technical training programs recognized by the Ministry of Education.

(二) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

Attending a Mandarin Language Center at a university or college approved by the Ministry of Education to admit foreign students, for a period totaling less than two years.

(三) 交換學生，其交換期間合計未滿二年。

Participating in a student exchange program for a period totaling less than two years.

(四) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

Interning in Taiwan with permission from the central competent authority for a period totaling less than two years.

具外國國籍並兼具中華民國國籍，且於本辦法中華民國100年2月1日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

Foreign nationals who also hold ROC nationality and who applied for the loss of ROC nationality before February 1, 2011, when this regulation was amended, may apply for admission under the original regulations, without being subject to the restrictions of the second item.

二、學歷資格(Academic Qualifications)

- (一) 在當地華文中學、外文中學畢業或相當於中華民國高級中學畢業取得畢業證書（以同等學力資格申請者須附修業證明書），且經我政府駐外館處查證屬實者。

Graduated from a Chinese or foreign-language high school or equivalent to a senior high school in the Republic of China (ROC), and the graduation certificate has been verified by ROC embassies or representative offices abroad.

- (二) 相當於中華民國高級中等學校肄業或畢業年級，高於相當中華民國高級中學學校之國外同級同類學校肄業並修滿相當於中華民國高級中學學校修業年限以下年級，符合下列資格之一者，或畢業年級相當於中華民國高級中等學校二年級之國外同級同類學校畢業生，得以同等學力資格申請：

Those who have completed or attended courses equivalent to the senior high school level in the Republic of China (ROC), or who have attended but not yet graduated from a foreign school of the same level and type as a senior high school in the ROC, and who have completed at least one grade level lower than the full study period at a senior high school in the ROC, and who meet one of the following conditions, or graduates from foreign schools of the same level and type equivalent to the second year of a senior high school in the ROC, may apply for admission under equivalent academic qualifications:

- (1) 僅未修習規定修業年限最後一年，因故休學、退學或重讀二年以上。

Have not completed the final year of the required study period due to suspension, withdrawal, or repeating the year for more than two years.

- (2) 修滿規定修業年限最後一年之上學期，因故休學或退學一年以上。

Completed the first semester of the final year of the required study period, but suspended or withdrew for more than one year.

- (3) 修滿規定年限，因故未能畢業。

Completed the required study period but was unable to graduate due to unforeseen circumstances.

上述休學、退學或重讀年數之計算，自修業證明書或休學證明書所附具歷年成績單所載最後修滿之截止日期起，計算至報考當年度註冊截止日為止。

The calculation of the suspension, withdrawal, or repeated years begins from the last recorded date of completion on the academic transcript or suspension certificate and is calculated up to the registration deadline of the application year.

- (三) 同等學力資格之認定應依教育部「入學大學同等學力認定標準」之規定辦理。

The recognition of equivalent academic qualifications must be processed in accordance with the Ministry of Education's "Standards for Recognizing Equivalent Academic Qualifications for University Admissions."

※ 凡有下列情形之一者，不得依本簡章之規定申請回國升學，違反規定者，取消錄取資格；已入學者，應令退學並撤銷學籍。

Those who meet any of the following conditions are not eligible to apply for return admission under this guide. Violation of these regulations will result in the cancellation of admission qualifications. If already enrolled, the student must withdraw and their student status will be revoked.

(1) 已申請喪失中華民國國籍經核准有案且尚未取得他國國籍者。

Those who have applied for and been approved for the loss of ROC nationality but have not yet obtained foreign nationality.

(2) 持偽造或冒用、變造證明文件或護照者。

Those who hold forged, borrowed, or altered documents or passports.

(四) 申請碩士班入學擁有副學士學位，以大學同等學力資格之認定報名，應依教育部「入學大學同等學力認定標準」之第五條第四款規定辦理。

Those applying for a master's program with an associate degree and using equivalent academic qualifications for university admission should follow Article 5, Section 4 of the Ministry of Education's "Standards for Recognizing Equivalent Academic Qualifications for University Admissions."

三、語言資格(Language Proficiency)

全校各系授課語言是華語為原則，語言能力門檻要求(應符合當地駐外館公告之基本法規標準為核)：

The language of instruction for all departments is Chinese. The language proficiency requirements should meet the basic regulatory standards announced by local embassies or representative offices:

1. 本專班申請入學時，華語文能力 A1(含)級以上或120小時(含)以上華語課程學習證明優先錄取。以1年時間確實提升學生之中文能力，入學1年內須通過華測 A2，否則逕予退學。Applicants with Chinese language proficiency at level A1 or above, or those who provide proof of having completed 120 hours or more of Chinese language courses, will be given admission priority. Students are required to significantly improve their Chinese proficiency within one year after enrollment and must pass the TOCFL Level A2 within the first year. Failure to do so will result in immediate dismissal from the program.
2. 需於開學前取得華語文能力證明文件(A1)或華語研習時數達120小時(含)以上，未於開學前取得者將取消入學資格。

Students must obtain a Chinese language proficiency certificate at Level A1 or above, or provide proof of having completed at least 120 hours of Chinese language study before the start of the semester. Failure to submit the required documents before the semester begins will result in disqualification from admission.

四、財力資格(Financial Requirements)

1. 國際一般生財力證明以美金3,500元為原則(應符合當地駐外館公告之基本標準為核)。

The financial proof for general international students should amount to USD 3,500 as a basic

principle (in line with the basic standard announced by local embassies or representative offices).

2. 學生擁有政府、大專校院或民間機構提供全額獎助學金證明，應提供本校及外館審核。

Students who have full scholarships provided by governments, universities, or private organizations must provide proof for verification by the university and the local embassy or representative office.

3. 財力證明不得採用代辦、公司行號或個人開立證明。

Financial proof cannot be issued by agents, companies, or individuals.

4. 學生還沒有最終的正式財力證明前，得要求學生先提供同一戶家人或足以證明為親屬關係之存款簿照片證明(或當地銀行開立之存款證明)。

Before the final formal financial proof is obtained, students may be asked to first provide a photograph of a family member's bank passbook or proof of savings (or a bank statement issued by a local bank) demonstrating their financial connection.

3. 最高學歷之外國畢業證書影本一份，暨該證書之英文或中文譯本一份（須經畢業學校所在地之中華民國駐外館處驗證並加蓋認證章戳，可於開學後繳交）；應屆畢業生須於錄取報到時補交，否則取消錄取資格。

A photocopy of the highest foreign diploma, along with its English or Chinese translation (The document must be verified and stamped with an authentication seal by the ROC (Taiwan) overseas mission located in the area of the graduating school and may be submitted after the semester begins.); graduating students must submit the documents at the time of enrollment, otherwise the admission will be canceled.

※錄取報到時，申請學士班者繳交高中畢業（結業）證書，申請碩士班者繳交副學士以上學位證書（只有專科學歷者，須提出五年以上與申請該系所碩士班相關之工作證明正本）於驗

證後歸還。

Upon enrollment, applicants to the bachelor's program must submit their high school graduation (or completion) certificate, while applicants to the master's program must submit an associate degree or higher diploma. Those holding only a junior college (associate) degree must provide official proof of at least five years of work experience related to the intended master's program. All documents will be returned after verification.

4. 中文或英文歷年成績單一份（須經由畢業學校加蓋認證章戳或鋼印密封，且在地之中華民國駐外館處驗證並加蓋認證章戳，可於開學後繳交）。

One official academic transcript in Chinese or English (The document must bear the official seal or embossed stamp of the graduating school, and be authenticated by the ROC (Taiwan) overseas mission responsible for the region where the graduating school is located. The document may be submitted after the semester begins.)

Bachelor's program applicants must include their high school academic transcripts, while master's program applicants must include their university academic transcripts.

Important Notes:

The application form must be personally filled out by the applicant. If there are any modifications, the applicant must stamp or sign at the modification area.

2. 申請資料寄〈送〉達後，經本校審查後發現報名資格不符、表件資料不全或逾期繳件而遭取消報考資格，概由考生自行負責。所有已寄〈送〉之申請文件一概不退還，請自行保留備份。申請費一經繳交，恕不退還。

Once application documents are submitted and reviewed by the school, if any discrepancies, incomplete documents, or late submissions are found, the applicant is responsible for the

cancellation of their application. All submitted documents will not be returned, so applicants should keep copies for themselves. Application fees, once paid, are non-refundable.

3. 申請者所繳之任何證明文件，經查如有偽造、變造、假借、冒用、不實者，未入學者取消錄取資格，已入學者開除學籍並不發給修業有關之任何證明文件，已畢業者或退學者除註銷學籍並繳銷其學位證書或修業證明書。涉及刑法偽造文書之刑責部份者，依法移送司法機關究辦。

If any submitted documents are found to be forged, altered, borrowed, falsely used, or fraudulent, the applicant's admission will be canceled if not yet enrolled. For enrolled students, their student status will be revoked, and no documents related to their academic achievements will be issued. For graduates or those who have withdrawn, their student status will be canceled, and their degree certificates or study certificates will be annulled. Cases involving the criminal offense of document forgery will be referred to judicial authorities for prosecution in accordance with the law.
